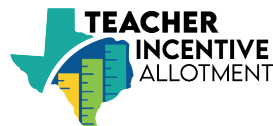
DESCRIPTION

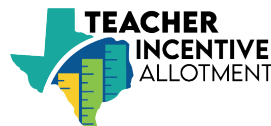

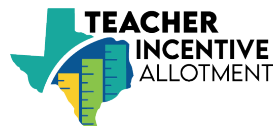
