# **Policy Updates**

#### 2020-2021 School Data Released

TDA must, on an annual basis, publish a list of schools participating in the National School Lunch Program (NSLP) in which at least one-half of the children enrolled are certified eligible for free or reduced-price meals. The report for 2020-2021, based on February 2020 claims data, has been posted to SquareMeals in the following locations:

#### New Emergency or Sole Source Purchase Process

We are excited to announce a new and consolidated process for requesting approval of an Emergency or Sole Source Purchase. All F&N Contracting Entities (CE) who are required to receive approval on these non-competitive purchases can do so by submitting a JotForm. Instructions below are incorporated within the form.

#### How does a CE submit an emergency or a sole source purchase request to TDA for approval?

- Go to <u>www.squaremeals.org</u>. On the right side of the landing page, you will see section identifying the various Nutrition Assistance Programs.
- Click on the Food Program that you are operating.
- · Click the link in the gold box titled "Emergency and Sole Source Request" to submit a request.
- The link will open a jot form and allow the CE to upload documentation and submit the information for the request.

#### Items to remember:

• When submitting the form please be mindful to **provide a complete description of the circumstances** that have occurred to justify the purchase request.

• **Be specific** on the specification (what needs to be purchased) and the **total cost or range of cost** based on estimates to support the price is reasonable.

• F&N cannot approve an open ended request.

• If TDA requires additional information to approve the request, an email will be sent to the person who submitted the JotForm.

#### **USDA Nondiscrimination Statement – Revision Notice**

This module explains the duties and responsibilities of the Verifying Official as part of processing Free & Reduced-price Meal applications. #### 2021/2022 CACFP Input Workgroup – Applications Open March 1, 2021

Applications for the 2021/2022 CACFP Input Group are now open. Every other month, Input Workgroup members meet virtually to gather input and discuss the current challenges and opportunities for CACFP in Texas. The input and feedback from these meetings help guide TDA as we work to provide the resources and trainings CACFP CEs need to successfully operate the CACFP in Texas. Since its inception, the collaboration between Input Workgroup members and TDA has yielded many tangible results not least of which is increased understanding between TDA and CACFP sponsors. If selected, Workgroup Members should be prepared to represent the perspective of their CACFP colleagues with TDA.

The application for membership is also available in the Applications section of the Texas Unified Nutrition Programs System (TX-UNPS) under Download Forms (CACFP-106).. Applications are due **Friday, April 23, 2021**. Membership selection is based on criteria such as sponsorship size, location, sponsor type, and response to the application questions. TDA's goal is to ensure that the group represents a broad and diverse range of CACFP sponsors and perspectives.

## **Important Reminders**

#### Community Eligibility Provision (CEP) Reporting

The CEP Report is due in TX-UNPS on March 20, 2021. Please note that March 20th is a Saturday; however, TX-UNPS is available 24/7. The Texas Department of Agriculture **is no**t granting due date extensions.



The TX-UNPS CEP Site Eligibility For School Year 2020-2021 will be

accessible on **March 1, 2021**. All CEs must complete the CEP Site Eligibility For School Year 2020-21 (commonly called the CEP List) in TX-UNPS. The CEP list reporting screen in TX-UNPS can be found by first navigating to the <u>Applications tab</u>. Once in the Applications tab, select <u>Community Eligibility Provision</u>. Select <u>Add</u> under the Action column for School year 2020-2021 located within the CEP Site List.

Please ensure accurate data entry, as the data will have a direct impact on claims for those that participate in CEP. The data entered is also reported to USDA and to the public.

#### **Financial Report**

The NSLP Financial Report is due **March 15, 2021**. This report must be completed by Contracting Entities (CEs) who participate in the NSLP, School Breakfast Programs (SBP), School Milk Program (SMP) or At-Risk CACFP programs and must be completed by an authorized representative. The NSLP Financial Report will not be available in TX-UNPS. An email with a jot form link for the Preparing for the Financial Report form has been sent to the Child Nutrition Director on the SNP Application.

The Preparing for the Financial Report form has been provided to prepare the CE in completion of the NSLP Financial Report. It contains a list of documents, terminology, object codes, and additional pertinent information related to the NSLP Financial Report.

Once the CE has completed review of this form and gathered the necessary documents, the CE will submit and will be directed to the NSLP Financial Report jot form.

CEs may also find PDF copies of the Preparing for the Financial Report, NSLP Financial Report, and Excessive Fund Balance Plan, the recording on the **NSLP Financial Report training**, and slide deck for the training presentation located on SquareMeals.

CEs may refer to Section 16 of the *Administrative Reference Manual* (ARM) on SquareMeals for compliance guidance on financial systems information.
