# **Policy Updates**

Release: Updated Instructions/Process

TDA has replaced its manual form H4529 – Authorization to Transfer USDA Foods with an electronic form process. This process is applicable to transfers between NSLP CEs served by the same state contracted warehouse and food



bank CEs participating in CSFP and/or TEFAP. New instructions for each applicable program are located on the Administration/Forms pages for those programs at the following links:

# **TX-UNPS Updates**

## PY 2021-2022 Application Reminders

The School Nutrition Program (SNP) site applications must be submitted and approved as a prerequisite for SSO application processing. SSO sites submitted for approval will be returned for correction if there are no SNP site applications in submitted and/or approved status.



#### Seamless Summer Option (SSO) Approved Site Application Behavior

An approved SSO site application in the prior program year may not automatically roll over to the next program year and populate in the SSO Site Application Site List. In these instances, sponsors should choose the "Add Site Application" function located at the bottom of the Site List and manually add the site application back to the Site List.

#### Seamless Summer Option (SSO) Closed Site Application Behavior

When an SSO site application is closed in the prior program year, it may roll-over to the current program year in Pending Validation status. In this eventuality, these site applications may be ignored or deleted at the sponsor's discretion

# ASCP Site Applications that reflect no pre-populated Free and Reduced Eligibility or less than 50% Free and Reduced Eligibility

When completing a site application for ASCP that does not meet area eligibility, the system will respond with an error message. To address this scenario, please follow these instructions:

Line number C4. Free and Reduced Enrollment Percentage:

- 1. Select second option, "Attendance Area Eligible Eligible based on another site (claim all snacks free)"
- 2. From the resulting drop-down menu, select "Other."
- 3. From the resulting text field, enter, "USDA waiver #85."

#### Seamless Summer Option Program Year 2022 (SSO PY22)

As of July 15, 2021, site applications in TX-UNPS are open for SSO PY22. Please update and submit all SSO site applications that you intend to operate for October 2021 through the end of the school year. Please see below for SSO site application guidance:

#### Site application naming convention:

- CONGREGATE ONLY: Use regular Site Name and Site ID#
- NON-CONGREGATE ONLY: Grab and Go use CVGG as the site name. For example, CVGG Brushy
  Oaks EL.
- NON-CONGREGATE/CONGREGATE COMBINATION: May be one site. Use CVGG as the site name.
   For example, CVGG Brushy Oaks El. Two separate site applications do not need to be completed.
- HOME DELIVERY: Use CVHD as the site name.

#### SPECIAL GUIDANCE FOR SSO SITES, please read carefully:

- 1. If the site does comply with standard area eligibility requirements, then complete the site as normal.
- 2. For sites that do not comply with standard area eligibility requirements please use the following guidance.

#### **OPEN/RESTRICTED OPEN Site:**

- 1. Indicate the type of site as Open or Restricted Open. If Restricted Open answer "Why is attendance limited/restricted due to security, safety or control?" (note- restricted open is still an open site, serving on a first come. first serve basis until capacity is met due to security, safety, or control).
- 2. Respond to "Qualified by:" choose "Other." Enter, "USDA waiver #85" in the "Explain" text field.

## CLOSED ENROLLED site:

Complete Section 13 Type of Site and Eligibility in the SSO site application in TX-UNPS

- 1. Indicate the type of site as Closed Enrolled
- 2. In the first text box enter "USDA waiver #85.
- 3. Answer "Why sponsoring a closed site" Covid Flexibilities
- 4. Respond to Qualified by: choose Other. Enter "USDA waiver #85" in the Explain text field
