

PEIMS and TSDS Update –February 2014

To comply with the new requirement in HB5 for community and student engagement evaluations, TEA has added new coding that will be reported in the PEIMS Submission 3 Summer Collection 2014. The following new fields have been added to both the 010 District and 020 Campus records, as districts will be required to rate themselves on both the district level and for each campus that is registered through AskTED:

The first 9 data elements above will be coded from Code Table C198:

The correct code for each LEA and campus will be assigned by a local committee charged with the task of determining criteria, evaluating, and assigning the rating for each entity.

The final code above will be coded from Code Table C088:

Code	Translation
0	Not Receiving Services, Or Condition Or Situation Not Applicable To This Person Or Campus
1	Participant In Program Or Service, Or Condition Or Situation Applicable To This Person Or Campus
